### **Coalition of Immokalee Workers' Supermarket Campaign**

By leveraging its high-volume purchasing power, the U.S. supermarket industry plays an active role in farmworker exploitation. This Thanksgiving, drop off a letter to the manager of **Trader Joe's**, Ahold (**Stop & Shop** and **Giant**), **Kroger** (also owns **Ralph's**) or **Publix**, asking the company to support fair wages and working conditions for farmworkers who harvest their tomatoes. #### **Healthy Families Act - Paid Sick Days**

The **Restaurant Opportunities Centers United** recently published a report based on over 4,000 surveys of restaurant workers nationally that found that 87% of restaurant workers do not receive paid sick days and 63% of restaurant workers go to work sick. You and/or your congregation can help by calling your Member of Congress and asking them to support the Healthy Families Act HR 2460 or SB 1152. The Healthy Families Act would provide all private sector workers with a total of 7 paid sick days per year. www.rocunited.org.
