

## BURMA: Joint Letter from Faith Leaders to President Biden Calling for Sanctions on Companies Supplying the Burmese Military with Jet Fuel

Dear President Biden,

We are writing to urge the U.S. government to demonstrate greater international leadership, coordination, and strategic influence in halting ongoing atrocities in Burma.

As people of faith, we affirm the inherent worth and dignity of every person and strive toward a world in which everyone can experience peace, justice, and liberty. Our sacred values demand that we act to protect the lives and human rights of the many people of Burma.

The U.S. government is uniquely positioned to lead the international community to have a significant impact in the region. The United States could impose targeted sanctions that would cut off the junta's access to funds and severely limit the dictatorship's access to financial resources.

The most recent round of U.S. sanctions, however, is unlikely to accomplish this goal. The sanctions targeting Asia Sun and others are unlikely to have a significant impact on the junta's ability to import jet fuel. This is especially true when solely targeting Burma-based entities, as junta allies can easily create new proxy companies that can then continue to import fuel without the sellers violating sanctions.

We urge you to prioritize impact over posturing in your sanctions regime, specifically by doing the following:

1. Sanction international companies selling jet fuel to the junta. Unlike the small Burma buyers that are easily replaced, the sellers are major international entities that would be seriously harmed by sanctions.

2. Prohibit companies from providing shipping insurance or shipping services to companies selling jet fuel to the junta. Without insurance, companies will not load cargo onto ships and ports will not allow them to dock. This would be the most effective and direct way for the United States to disrupt the flow of jet fuel into Burma.

3. Impose sanctions on the Myanmar Oil and Gas Enterprise (MOGE) to impact one of their largest revenue streams, which funds the junta's campaign of violence against the people of Burma

The people living under a violent, unelected regime in Burma need more than toothless sanctions and farcical announcements. They risk their lives daily to protect their community from harm. They would benefit from targeted sanctions with fewer loopholes, harsher penalties, and stronger enforcement, while ensuring access to humanitarian aid directly to those working with the impacted community.

The United States has a moral obligation to end human rights violations in Burma. Doing business with the Burmese junta is nothing short of funding genocide, mass atrocities, displacement, and the oppresssion of hundreds of thousands of civilians. If the United States chooses not to implement policies that could end this violence, the United States will be abetting genocide. Taking concrete action in the form of economic sanctions sends a clear and resounding message: **We will not be complicit in the mass violence and death perpetuated by the junta**. As people of faith, we urge you to take action now.
