

UUSC's program emboldens the principle of the right to self-determination by prioritizing building protections in place and when necessary and required by our partners, supporting communities to relocate with dignity. In addition to directly supporting communities at risk, UUSC has a multi-pronged strategy that targets a range of stakeholders to assist communities as they advance their right to self-determination and develop strategies to respond to the spectrum of risks associated with climate-forced displacement.

In alignment with our principles, UUSC's strategy upholds the timeless adage that civil society organizations around the world share, "Nothing about us, without us." This recognizes the grave injustices that frontline communities have experienced through legacies of imperialism, colonialism, exploitation of Indigenous bodies and lands, and the forcible displacement that many have faced in the name of western modernization. CSJ continues to focus on being both catalyst and connector, teachers and designers of learning containers, accomplices and partners providing fortification for the long-haul work of shaping a more just and joyful world. We accomplish this through collaboration, co-creation, and curation of a variety of experiential learning programs, partnerships, workshops and resources designed for and with UUSC partners, UU congregations and UU-adjacent partners. UUCSJ supported the first in-person UU youth justice journey with catalyst partner organization BORDERLINKS and developed resources required for supporting youth groups through immersive learning journeys, as risk tolerance for travel begins to expand.
